

## **Guidelines for Application of Accreditation as Presidential Anti-Corruption Commission (PACC) Partner Organization and Partner Individual**

- Any private individual of good repute and character and/or organization of good 1. standing from the private sector may be accredited as PACC Partner Individual and PACC Partner Organization by signifying their intention through a letter addressed to the PACC Commission En Banc, stating the reason/s for their application.
- 2. There will be no employer-employee relationship or affiliation created between PACC Partner Organization/Individual with the PACC. All acts done by the accredited organization/s and its respective representative/s and the commissioned individuals shall not be compensated in any form or manner, but, in the spirit of volunteerism, are willing to share their time and effort in support of the PACC's mandate to fight graft and corruption.
- Interested applicants shall fill up the application form available at PACC Main Office 3. located at Ground Floor, Palacio del Gobernador, Intramuros, Manila or through PACC website. The applicant must comply with all the requirements stated therein. No accreditation shall be processed until all the requirements are submitted and met.
- The applicant individual, organization and its representative shall be subjected to 4. background check for security and clearance purposes. The applicant must submit or comply with the clearances as stated in the application form.
- 5. At any time during the application process, the applicant individual and/or organization and its representative shall be scheduled for interview.
- 6. Successful applicants shall be notified of the approval/grant of the commission or accreditation which they will be issued a Certificate of Accreditation/Commission.
- The Commission En Banc reserves the right not to disclose the reason of the approval or 7. denial of application.
- 8. The successful applicant individual and/or organization and its representative cannot use its PACC accreditation or commission for its own purpose, other than for the specific assignments or tasks which will be given to them by the Commission En Banc.
- 9. In case of assignment to a particular investigation, if any, the accredited organization and its representative and/or commissioned individual/s are restricted to perform certain acts based on specific instructions by the Commission En Banc, upon the advice and recommendation of the Investigation Service.
- 10. All successful applicants shall sign a Non-Disclosure Agreement which shall be strictly implemented at all times even after the expiration, termination, or cancellation of the accreditation/commission.
- 11. The PACC has the right to cancel the accreditation/commission of its partner individual and/or organization for cause or upon the discretion of the Commission En Banc.
- 12. All PACC Partner Organization/s, its representative/s, and PACC Partner Individual/s shall **NOT REPRESENT** in any way or manner the PACC, its Commissioners, officers, and/or employees and they shall bear all the consequences of their unlawful or illegal acts and misrepresentations.
- The PACC Partner Organizations, its representatives, and PACC Partner Individuals shall 13. be under the direct control and supervision of the PACC.
- The PACC accreditation and commission of the successful applicants shall be reviewed 14. yearly which may or may not be renewed.
